The above committee members are requested to conduct preliminary enquiry if any complaints arises from students so as to ascertain the truth of the allegation by collecting the documentary evidence as well as recording statements of any possible witnesses including the complaint. ICC shall submit the preliminary enquiry report to the Principal along with all the original documents adduced during the preliminary enquiry proceedings. In case the allegations are not in the nature of sexual harassment, ICC may refer such complaints to the Grievance Redressal cell.

Where sexual harassment occurs as a result of an act or omission by any third party or outsider, ICC shall take all steps necessary and reasonable to assist the affected person in terms of support and preventive action.

ICC shall be comply with the procedure prescribed in the relevant regulations in vogue and the sexual harassment act for inquiring in to the complaint in a time bound manner.

If ICC concludes that the allegations made were false, malicious or the complaint was made knowing it to be untrue or forged or misleading information has been provided during the enquiry, the complaint shall be liable to be punished as per the relevant provision of the aforementioned regulations.
